**THIS TICKET PURCHASE AGREEMENT** (the Agreement) is entered into by the person or entity named above (the Account Holder) and **NORTH BAY BATTALION HOCKEY CLUB LTD.**, owner of an Ontario Hockey League franchise operating at Memorial Gardens, North Bay, Ontario.

By signing below, the Account Holder agrees to these terms and conditions.

- 1. TERM:** The Account Holder has the option to select one of the following season ticket subscriptions and shall indicate which option is to be selected by checking beside same:
  - One-year (1) subscription commencing July 1, 2018, and concluding on June 30, 2019 (single-season commitment);
  - Three-year (3) subscription commencing July 1, 2018, and concluding on June 30, 2021 (three-season commitment) with an annual price increase of no greater than 3.0%;

**2. 2018-19 SEASON FEES:** The annual subscription fee for 2018-19 season tickets shall be as follows:

\*ticket pricing per seat includes all taxes and surcharges for one year

**3. PAYMENT PLANS:** Account Holders shall have the following payment options with regard to season ticket subscriptions:

(a) Lump sum payment representing balance due in full on or before September 1, 2018, for the initial season and on or before September 1 of each subsequent season;

(b) Five equal monthly installments payable

May 1, 2018

June 1, 2018

July 1, 2018

August 1, 2018

September 1, 2018

Payments returned by a financial institution or not processed by a credit card shall result in a \$25.00 handling fee charged to the Account Holder.

**4. PLAYOFFS:**

Admission to any Playoff Games of special OHL events at Memorial Gardens in which the Team or its players may participate, is not included under this Agreement or as part of the Account. The Team shall provide the Account Holder a first right of refusal to purchase tickets for playoff games to be exercised within the time period set out in notices provided by the Team.

**5. TRANSFERABILITY:**

The within Agreement may be transferable with the consent of the Team with such consent not to be unreasonably withheld.
